ORDINANCE #24-0423B, AN ORDINANCE DEDICATING LAND SITUATED AT 2 S OAKLAND RD, ASHMORE, ILLINOIS AS A PUBLIC PARK

Whereas the VILLAGE OF ASHMORE previously had land at 2 S. Oakland Rd, Ashmore, Illinois conveyed to it in order that it might engage in the demolition of a dangerous or unsafe residential tract of real property,

Whereas the VILLAGE OF ASHMORE has demolished the residential structure and determined that the land is a parcel that would be useful, advantageous, necessary or desirable for the municipal purpose and public welfare of citizens as a public park,

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE VILLAGE OF ASHMORE TRUSTEES, as follows:

The land commonly referred to as 2 S. Oakland and legally described as follows: The North Half (N.1/2) of Lot One (1) and the North Half (N.1/2) of Lot Two (2) EXCEPT the West 23 feet of the North half (N.1/2) of Lot Two (2) in Block Ten (10) in the original town, now village of Ashmore, Coles County, Illinois; PIN: 01-0-02901-000;

Is hereby dedicated to the purpose of public park, and such park shall be known as and referred to as Serenity Corner.
